## Stream Partners Program

**West Virginia Stream Partners Program** is a cooperative effort of the Department of Environmental Protection, the Division of Forestry, the Division of Natural Resources and the West Virginia Conservation Agency.

#### Purpose

To support community groups that are dedicated to assuring that their local rivers and streams are safe for: swimming, fishing, recreation, public and commercial purposes and provide habitat for plant and animal life.

#### How to get started

\$5,000 seed grants are available each year to applicants that are willing to organize community members to plan and complete a watershed improvement project. Applications are available online at <a href="http://www.wvca.us/stream.cfm">www.wvca.us/stream.cfm</a>.

#### **Basin Coordinators**

Four regional basin coordinators are available to:

- Help complete applications
- Advise on projects with agency and assist with partnership building
- Get your community involved by helping to organize and facilitate meetings

#### The Partners

In September of 2010 the West Virginia Stream Partners Program awarded twenty-two local watershed associations grants of up to \$5,000. These watershed volunteers spent the year coordinating their goals with those of state and federal agencies, local government and watershed stakeholders to implement projects that range from educational field days to on the ground stream restoration. Each of these organizations is very unique. Each has its own set of skills, abilities and obstacles.

The Stream Partners Program provides the volunteers with a small financial resource, technical support, and organizational skills. This annual yearbook will highlight each association's individuality and successes.

The West Virginia Stream Partners Program is truly a state-wide cooperative effort. Program support is provided by staff from each of the four partner agencies and the grant fund is an annual legislative appropriation.





The strategy from the beginning has been to promote coalition building and shared commitments, minimizing confrontational and adversarial approaches. The FOC's membership, approximately 550, represents the whitewater and coal industries, elected officials, small businesses, landowners, residents, recreational users, academia, environmental advocacy, and a subwatershed association.

#### Who We Are

The group, formerly known as Concerned Citizens of Alderson/Glen Ray, was founded and chartered in 1990 as a 501(c)3 organization. The group was formed in reaction to a significant threat to the groundwater and wells of the citizens of Alderson and Glen Ray - a CCA pressure treated wood plant was being built on the banks of the Greenbrier River in the flood plain. As a result, an ad hoc group of citizens came together and battled for the safety of the local drinking water for five years. The vigilance of the Concerned Citizens of Alderson/Glen Ray resulted in the closure of the polluting plant and the enforcement of state environmental laws in requiring the property owner to comply with permitting procedures.

Since that time, Concerned Citizens of Alderson/Glen Ray has monitored and intervened in the bankruptcy proceeding to guarantee groundwater and site clean up. The group has kept the public apprised of continuing action with press releases and letters to the editors of local papers.

In the spring of 1999, the Concerned Citizens of Alderson/Glen Ray changed the group name to Friends of the Lower Greenbrier River. The name change reflects an interest in broadening the geographic scope of the group's activities to include the entire lower Greenbrier river watershed, and to include a broader mission of monitoring and improving water quality and educating residents and seasonal recreational river visitors about water quality issues.



#### Who We Are

The Wastewater Treatment Coalition of McDowell County (WTCMC) came into existence after the 2001 and 2002 floods ravaged communities. These floods affected over 7,000 homes, causing more than \$66,000,000 in damages. Rebuilding efforts brought forth the critical need to address the historical lack of adequate wastewater treatment. The WTCMC formed at the charge of U.S. Congressman Nick Rahall's representative to complete a countywide assessment and design for addressing sewage issues collectively. Upon completion, the Congressman's office assisted in leveraging dollars for implementation of the plan. In February 2003, 23 agencies, faith-based, nonprofits, higher education, traditional and nontraditional wastewater system agencies, government and regional organizations met to form a coalition that could meet the charge for the county. The WTCMC immediately began an assessment of existing wastewater treatment in the county, and started educating themselves on both traditional and alternative approaches to wastewater treatment. The WTCMC developed an organizational structure to address their priorities: researching various technologies including site visits and internal workshops, identifying potential management models and prevailing regulations, and developing prioritization criteria to rank the many identified projects.
