PRE-SITING REQUIREMENTS FOR A COMMERCIAL SOLID WASTE FACILITY

Any persons investigating an area for the purpose of siting a commercial solid waste facility where no current solid waste permit exists, in order to determine a feasible, approximate location, shall comply with the pre-siting notice requirements of 33CSR1 subdivision 3.4. and W.Va. Code §§22-15-13. There are basically two steps in the initial pre-siting notice process, as follows.

STEP 1: PUBLISH A CLASS II LEGAL ADVERTISEMENT

A Class II legal advertisement shall be published by the applicant in a qualified newspaper serving the county or counties were the proposed site may be located. This legal advertisement must include the following:

- 1. The applicant's name and mailing address
- 2. Nature, description, and type of proposed facility
- 3. Anticipated size of proposed facility in acres
- 4. Anticipated life of facility
- 5. Location of facility to include:
 - a. Nearest post office (city or town)
 - b. Magisterial district(s)
 - c. County or counties
 - d. Nearest stream
 - e. Receiving stream
 - f. Major drainage basin
- 6. An estimate of the volume, type and source (city, county and state) of the solid waste proposed to be handled at the facility
- 7. Location map (scale 1" = 1 mile) with detail commonly found on a West Virginia General County Highway map to include:
 - a. A map size minimum two (2) inches by two (2) inches (suggested size 4" x 4")
 - b. Longitude and latitude of the center of the site and these two lines shown on the map at the center of the proposed site
 - c. A north arrow
 - d. Information pertinent to the identity (name) of the highway map utilized

STEP 2: FILLING REQUIREMENTS OF A PRE-SITING NOTICE WITH THE APPROPRIATE AGENCIES

Within five (5) days following the publication of the Class II legal advertisement, two (2) copies of a pre-siting notice, made in writing on forms obtained from the Director, signed and verified by the applicant, must be filed with:

In addition, one (1) copy shall be filed with the appropriate county or regional solid waste authority, county commission and/or other entities established pursuant to W.Va. Code §§22C-4, and §§22-15-13 according to the county or region in which the proposed facility or facilities may be located.

Each pre-siting notice shall include:

- 1. As an attachment, a notarized certification of an original publication of the legal advertisement from the qualified newspaper in which the advertisement was published as it appeared in the newspaper
- 2. The applicant's name and mailing address
- 3. Nature, description and type of proposed facility
- 4. Anticipated size of proposed facility in acres
- 5. Anticipated life of facility
- 6. Location of facility to include:
 - a. Nearest post office (city or town)
 - b. Magisterial district(s)
 - c. County or counties
 - d. Nearest stream
 - e. Receiving stream
 - f. Major drainage basin
- 7. An estimate of the volume, type and source (city, county and state) of the solid waste to be handled at the facility
- 8. Location map (scale 1" = 1 mile) with detail commonly found on a West Virginia General County Highway map to include:
 - a. A map size minimum two (2) inches by two (2) inches (suggested size 4" x 4")
 - b. Longitude and latitude of the center of the site and these two lines shown on the map at the center of the proposed site
 - c. A north arrow
 - d. Information pertinent to the identity (name) of the highway map utilized
- 9. Period of time over which the investigative review the applicant will need to determine the feasibility of the site

- 10. A 7.5 minute USGS topographic site plan map or portion thereof and a map (8 1/2" x 11" or larger) to include:
 - a. The location of the site and anticipated property
 - b. The site
 - c. Other boundaries of each site being considered
 - d. All areas within one thousand five hundred (1,500) feet of the site boundaries
 - e. A north arrow
 - f. The USGS quadrangle with date of latest revision
- 11. Any additional information required by the Director.

Note: The information provided in Step 2, Items 2 through 8, must be identical to the information published in the Class II Legal Advertisement.
