Directions:	From Old US Rt. 33 in Buckhannon, proceed approximately 15 miles to Secondary Rt. 53 (Pumpkintown-Coalton Road). Turn right on Secondary Rt. 37/8 and proceed through the town of Mabie. Make a right onto Secondary Rt. 35 for 5.5 miles to a sharp left hand curve in Cassity. Station access road goes to the right on a gravel road in this curve.

### Facility Description

The Mabie Station is a natural gas transmission facility covered by NAICS 486210 and SIC 4922. The station has the potential to operate seven (7) days per week, twenty-four (24) hours per day. The station consists of two (2) 250-hp and one (1) 600-hp natural gas fired reciprocating engines, one (1) non-emergency generator, and five (5) storage tanks of various sizes.

### Title V Program Applicability Basis

This facility has the potential to emit 195.20 TPY of CO and 115.97 TPY of NO<sub>x</sub>. Due to this facility's potential to emit over 100 tons per year of criteria pollutant, Energy Corporation of America is required to have an operating permit pursuant to Title V of the Federal Clean Air Act as amended and 45CSR30.

### Legal and Factual Basis for Permit Conditions

The State and Federally-enforceable conditions of the Title V Operating Permits are based upon the requirements of the State of West Virginia Operating Permit Rule 45CSR30 for the purposes of Title V of the Federal Clean Air Act and the underlying applicable requirements in other state and federal rules.

This facility has been found to be subject to the following applicable rules:

Each State and Federally-enforceable condition of the Title V Operating Permit references the specific relevant requirements of 45CSR30 or the applicable requirement upon which it is based. Any condition of

the Title V permit that is enforceable by the State but is not Federally-enforceable is identified in the Title V permit as such.

The Secretary's authority to require standards under 40 C.F.R. Part 60 (NSPS), 40 C.F.R. Part 61 (NESHAPs), and 40 C.F.R. Part 63 (NESHAPs MACT) is provided in West Virginia Code §§ 22-5-1 *et seq.*, 45CSR16, 45CSR34 and 45CSR30.

**Determinations and Justifications**

**Revisions to Section 4.0: Reciprocating Engines**

This section addresses all the reciprocating engines at this facility and primarily references 40 CFR 63, Subpart ZZZZ. Since the previous permit renewal, this rule has been revised. As a result, the following changes have been made with this permit renewal:

- A reference to 45CSR34 was added to all conditions that reference 40 CFR 63, Subpart ZZZZ.
- Conditions 4.1.1.a and g (formerly h), which contain the applicable portions of Tables 2d and 6 to 40 CFR 63, Subpart ZZZZ were revised to reflect the current language.
- Condition 4.1.1.b of the previous permit renewal contained language from Table 1b to 40 CFR 63, Subpart ZZZZ. However, this table no longer contains applicable regulations to this facility since the subpart was revised. Therefore, it was not included with this renewal.
- Conditions 4.2.1, 4.2.2, 4.4.1, and 4.4.2 incorporated requirements from 40 CFR 63, Subpart ZZZZ by reference in the previous permit renewal. These conditions were written out with this permit renewal.
- Condition 4.3.1 included testing requirements from 40 CFR 63, Subpart ZZZZ by reference in the previous permit renewal. However, the testing requirements have changed since the rule has been revised. The new language in this condition addresses initial compliance demonstration and use of NSCR.

### Non-Applicability Determinations

The following requirements have been determined not to be applicable to the subject facility due to the following:

45CSR21	<i>Regulation to Prevent and Control Air Pollution from the Emission of Volatile Organic Compounds.</i> Mabie station is not located in Cabell, Kanawha, Putnam, Wayne, or Wood counties that are affected by 45CSR21.
45CSR27	<i>To Prevent and Control the Emissions of Toxic Air Pollutants.</i> Natural gas is included as a petroleum product and contains less than 5% benzene by weight. 45CSR§27-2.4 exempts equipment used in the production and distribution of petroleum products providing that such equipment does not produce or contact materials containing more than 5% benzene by weight.
40 C.F.R. 60 Subpart GG	<i>Standards of Performance for Stationary Gas Turbines.</i> There are no turbines at the Mabie Compressor Station.

Therefore, the facility is not subject to the Compliance Assurance Monitoring (CAM) rule.
