Melanie Hankins:

Antero Resources Corporation (Antero) would like to submit the following permit modification for an approved well on the existing Edwin Pad. While building the curve during drilling of the Moats Unit 2H (API# 47-085-10080), the wellbore ended up approximately 175' off the original permitted path. WVDEP Inspector Mike Goff was notified on 8/20/2015 and gave approval to continue drilling this well back towards the original permitted path.

In order to accommodate appropriate spacing for the offset Moats Unit 1H well (API# 47-085-10079), we are requesting to slightly move the horizontal lateral at the landing and turning points as shown on the attached REVISED mylar plat. Please note that we will not be drilling into any new leases, and all other work will stay the same as originally permitted.




